
PRIVATE PROPERTY RIGHTS AWARD

PURPOSE

Originally established to honor the exceptional work in public policy and property rights advocacy of REALTOR® Richard C. Dils, the Private Property Rights Award honors a REALTOR® or staff member who exemplifies hard work and commitment to government affairs affecting REALTORS® and the real estate profession. The Award is presented at the Margaret C. Carlson REALTOR® Day on Beacon Hill to honoree(s) who commit their time, passionately, to the betterment of the profession through continuous advocacy, efforts to understand legislative issues, and involvement in government affairs and the REALTOR® Political Action Committee.

SELECTION COMMITTEE

The selection committee shall be comprised of: Immediate Past President as Chair, President, President-Elect, Chair of the Government Affairs Committee, Immediate Past Recipient, MAR CEO/EVP (non-voting), and MAR Government Affairs Director (non-voting). The Selection Committee shall meet annually to review candidates. Selection shall be at the discretion of the Committee, including deciding whether anyone is deserving of the Award that year.

AWARD ELIGIBILITY

MAR members or staff, including those who are also legislators or state officials, are eligible for the award. No one on the Selection Committee is eligible.

Activities to be considered when deciding who may be deserving of the Award:

- Serving on the Government Affairs Committee locally, at MAR, or NAR.
- Attending and participating in the Margaret C. Carlson REALTOR® Day on Beacon Hill, other MAR Legislative Meetings and NAR Legislative Meetings.
- Attending or speaking at local and/or state public hearings.
- Meetings with local, state, or federal legislators and officials.
- Educating REALTORS® and/or the public regarding private property rights, housing and economic development, and other real estate or brokerage issues.
- Investing in the REALTOR® Political Action Committee.
- Inspiring or mentoring the involvement of others in government affairs.
- Exhibiting leadership qualities and taking leadership roles in local, state, and national government affairs.
- Other extraordinary volunteerism and/or service in government affairs.

TIME AND PLACE OF PRESENTATION OF THE AWARD:

Announcement of the recipient and initial presentation of the Award shall be made at the Margaret C. Carlson REALTOR® Day on Beacon Hill, or if held virtually, during MAR’s Virtual Week of Advocacy. The recipient shall also be recognized at the MAR Awards Night that same year.
